

D.S.R. SIDER ENGINEERING GROUP S.P.A., as the data controller, informs you that a video surveillance system is in operation with image recording for the protection of company assets and the safety of individuals.



1. WHO IS THE DATA CONTROLLER?

2. WHAT PERSONAL DATA DO WE COLLECT AND PROCESS?

The following personal data may be processed:

- Image.

In compliance with applicable laws, appropriate signage informs individuals entering or within the video surveillance area.



3. FOR WHAT PURPOSES DO WE PROCESS PERSONAL DATA AND WHAT IS THE LEGAL BASIS?

The data related to video recordings will be processed exclusively to protect company assets and ensure the safety of individuals.

The **legal basis** for processing is the legitimate interest of the data controller.



4. DATA RETENTION PERIOD

The recorded images are retained for 24 hours from the time they are captured, except during periods of closure or in response to specific investigative requests from the Judicial Authority in case of criminal activity.

At the end of the retention period, the images are automatically deleted from the system.



5. WHO MAY HAVE ACCESS TO THE DATA?

The viewing and extraction of recorded images are restricted to Management and specifically authorized personnel. In the event of damage or criminal incidents, the recorded images will be transferred to a digital medium and delivered to the competent authorities.

Personal data related to this processing, for the purposes of protecting company assets and ensuring the safety of individuals, may be communicated to legal professionals, the Judicial Authority, and/or law enforcement agencies.



6. RIGHTS PROVIDED BY LAW

European data protection law ("GDPR") provides several rights that you can exercise to maintain control over your data. To exercise your rights, you can write to privacy@dsrsider.it. We are required to respond within 30 days of receiving your request and will strive to do so as quickly as possible.

Right of access: You have the right to obtain information regarding the processing of your personal data and to access and receive a copy, including through commonly used electronic means. We are committed to providing you with a report of the data we hold, such as your personal details, contact information, or requests we have received via contact forms or e-mail.

Right to rectification: You have the right to obtain the update, integration, or rectification of your data. If you believe your data is incorrect or outdated, please contact us—we will do our best to resolve the issue.



Right to data portability: You may request the portability of your data, processed based on contract performance or your consent.

Right to erasure: You have the right to request the deletion of your data. We are committed to giving you control over your data. In some cases, you can request direct deletion, and we will act as quickly as possible. However, not all data can be deleted upon request, as it may be necessary to fulfill legal obligations or because it is still in use.

Right to restriction and objection: You have the right to request the restriction of processing or to object, in whole or in part, to the processing of your personal data, including for marketing purposes. When you request the restriction of processing, we are required to suspend all data processing activities for a specified period. When you object to the processing, you can unilaterally decide to opt out of a particular type of data processing.

If you believe that one or more of our processing activities may violate the law, or if you believe that your rights have not been protected, you can file a complaint with the Supervisory Authority in the place where you usually reside or where the alleged violation occurred. In Italy, you can contact the Data Protection Authority ("Garante Privacy").
